Candidates will strongly contribute to one of the faculty's research foci and actively contribute to applying for joint research funding. Teaching in German and English at bachelor, master, and PhD levels is required. In teaching, the professorship is part of the Master's areas "Finance, Banking and Insurance" and "Accounting, Taxation and Public Finance". The applicant should have an appropriate teaching profile.
